- NC has total 59,158 confirmed cases, with 1,348 deaths. Our state currently has 20,959 active cases and 892 hospitalizations.
  - Beaufort County has had a total of 75 cases, with 21 currently active, and 1 hospitalization. Beaufort County Health Department is reporting its first death in the county of a resident who tested positive for COVID-19. (See the attached press release for additional details.) Twenty-three (23) of our positive cases were asymptomatic. (Meaning they experienced no COVID-19 symptoms.) Investigation of these known cases have concluded:
    - (47) cases are attributed to direct contact with another known positive case.
    - (2) cases were related to travel to a known outbreak area.
    - (23) cases are attributed to community spread.
    - (2) case still under investigation.
- All active cases are self-isolating.



- Eastern NC counties with total confirmed cases include: Bertie, (140), Beaufort (75), Bladen (344), Brunswick (440), Carteret (67), Camden (23), Chowan (19), Columbus (494), Craven (338), Currituck (16), Dare (40), Duplin (1,398), Edgecombe (298), Gates (26), Greene (164), Halifax (297), Hertford (157), Hyde (6), Jones (32), Lenoir (352), Martin (122), New Hanover (765), Northampton (193), Onslow (243), Pamlico (18), Pasquotank (180), Pender (221), Perquimans (32), Pitt (638) Sampson (973), Tyrrell (8), Washington (37), Wayne (1,724) and Wilson (665). Mecklenburg (9,944), Wake (4,551), and Durham (3,451) counties have the most cases.

# FACE MASKS

## WHAT TO KNOW:



They are **REQUIRED** in:

- Retail businesses
- Restaurants
  - *Except when actively eating or drinking*
- Personal Care, Grooming, and Tattoo businesses
  - *Except if they are receiving a facial treatment, shave, or other services*
- Child Care Facilities, Day and Overnight Camps
  - *Except if they are under 11 years old*
- State Government agencies
- In transportation
  - *Airports, bus, and train stations/stops, as well as ride-shares, cabs, and shuttles*

- High-density Occupational Settings
- Meat or Poultry Processing Plants
- Long-Term Care Facilities
- Health Care Settings

### EXCEPTIONS:

- Medical or behavioral condition or disability
- Under 11 years old
- Strenuous exercise
- In a personal vehicle
- Working at home
- Actively eating or drinking
- Giving a speech
- Seeking communication with someone who is hearing impaired that requires the mouth to be visible



## **Re-Opening Timeline / Guidelines**

Below is a summary of our states plan for a phased reopening. Please note that these timelines / guidelines are subject to change based on case trends and / or additional executive orders.

### **Phase II (Will begin at 5pm Friday, 5/22 and continue through 7/22)**

Governor Cooper has announced that North Carolina's Phase II "Safer at Home" order has been extended for 3 additional weeks (thru 7/22).

Today's announcement also included an executive order requiring individuals above the age of 11 to wear a face covering while in public areas where social distancing cannot be maintained. Exceptions are permitted for those individuals with medical issues that prohibit the use these coverings.

Lifts the Stay-at-Home order. Restaurants and Personal Care Services must follow safety protocols including the potential need to reduce capacity. **(Bar & Fitness Centers will remain closed under Executive Order 141)**

Increases number of people allowed at gatherings

Requires face coverings in public spaces when 6 ft of distancing isn't possible.

### **Phase III (Could begin July 22, 2020)**

Increased capacity at Restaurants, Bars, Other Businesses & Entertainment Venues.

Further increase the number of people allowed at gatherings.

- The following Executive Orders have been issued for North Carolina.
  - EO 147: Takes effect on June 26<sup>th</sup> and extends Phase II “Safer at Home” orders and requires the use of face coverings.
  - EO 146: Extends certain transportation-related provisions in previous executive orders.
  - EO 144: Extends certain health and human services provisions in previous executive orders.
  - EO 143: Addresses disparities in communities of color that historically have had less access to health care, housing, economic opportunity and more.
  - EO 142: Extends the prohibition of utility shut-offs and implements a moratorium on evictions.
  - EO 141: Lifts the statewide Stay at Home Order and moves the state to a Safer At Home recommendation. Allows restaurants to resume dine-in services, and Barbers, Salons and Personal Care businesses to open.
  - EO 139: Provides additional regulatory flexibility to help ensure capacity in the state’s health care system and improve its ability to effectively respond to the COVID-19 pandemic.
  - EO 138: Effective 5 p.m. May 8, 2020, eases some restrictions on travel, business operations and mass gatherings.
  - EO 135: Extends until May 8, North Carolina’s Stay At Home (Executive Order 121) as well as other orders regarding the closures of restaurants for dine-in service, bars and other close-contact businesses
  - EO 134: Allows furloughed employees to be eligible for unemployment benefits.
  - EO 133: Extends certain provisions in previous executive orders that are related to transportation.



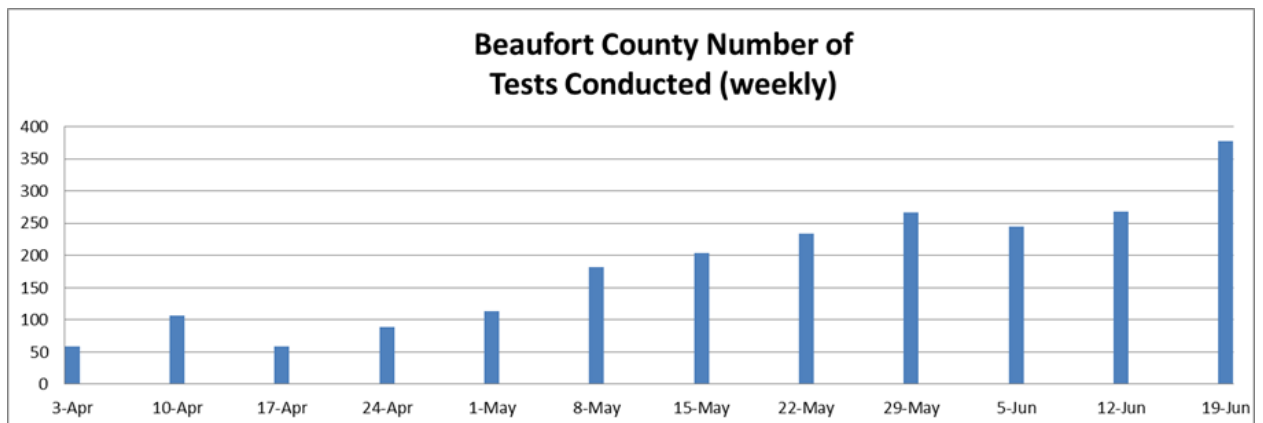
- EO 131: Addresses three issues: requires retail stores that are still operating to implement new social distancing policies to make shopping safer for customers and employees; makes earlier COVID-19 guidelines mandatory for nursing facilities, and recommends other long-term care facilities to do the same; speeds up the process to get benefits to people out of work.
- EO 130: Provides more access to health care beds, expands the pool of health care workers and orders essential childcare services for workers responding to the crisis.
- EO 124: Prohibits utilities - including electric, gas, water and wastewater services from disconnecting people who are unable to pay during this pandemic and prohibits them from collecting fees, penalties or interest for late payment. The order applies for the next 60 days and gives residential customers at least six months to pay outstanding bills.
- EO 121: A statewide “Stay at Home” order has been issued. This order will restrict travel to essential activities only. (ie. Travel for items such as, groceries, food, medications, household supplies, essential workers, etc.) This order will also limit gatherings to less than 10 people.
- EO 120: Extended school closures through May 15<sup>th</sup>. This order also imposes restrictions on the following businesses; Bingo Parlors, Bowling Alleys, Indoor Exercise Facilities, Health Clubs, Indoor / Outdoor Pools, Live Performance Venues, Movie Theaters, Skating Rinks, Spas, Gaming and businesses which allow gaming activities.
- EO 119: Lifting restrictions on local Health Departments, childcare facilities, and commerce transport. This order also restricting various functions of DMV to include:
  - Driver’s License Office will operate by appointment only.
  - Closing of all Drivers License Office that are on insufficient size to maintain social distancing.
  - Extending office hours at locations that are of sufficient size.
  - Postpone all DMV related hearings for 60 days.
- EO 118: Restricting dine-in services at all restaurants / bars. These businesses will continue to be allowed to provide carry-out and delivery services.





## Testing

- There have been 1,936 tests completed in Beaufort County to date, with 1,717 negatives, 67 positives and 152 pending. (These are cumulative numbers and includes test performed at the Health Department and reporting private medical facilities throughout our county.) **\*Eight (8) of our positive cases were tested in other counties but are Beaufort Co. residents.\***
- There were 378 tests completed by Beaufort Co. agencies last week. This was our highest weekly total to date and exceeds the state's recommended pace of testing 2% of a county's population per month. (Equating to approximately 240 people per week for Beaufort Co..)

# ONCE YOU'VE BEEN TESTED FOR COVID-19...

## 1. STAY HOME

Self isolate yourself, within your home, from others around you.



## 2. ANSWER YOUR PHONE



Results should be received within 72 hours. The Health Department will contact you daily to check in on you & will call with your results once they are received.

## 3. YOUR RESULTS

In addition to you being given your results over the phone, a copy will also be mailed to you.



### IF POSITIVE



You are to isolate yourself at home for at least 10 days from the onset of symptoms **AND** until you can go 72 hours fever free without the use of fever-reducing medication **AND** have an improvement in respiratory symptoms.

### IF NEGATIVE

When notified of your test results, the nurse will give you further guidance regarding monitoring, based on your situation





## **Resources**

### **“Check My Symptoms”**

NCDHHS has created a “Check My Symptoms” tool that will help you check your symptoms online and determine if you will be recommended to be tested for COVID-19. After you enter your symptoms, if it is recommended that you get tested, you will receive a list of nearby testing sites via email or text. This is an informational tool to help you determine if you may need to be tested; however it is not a physician order. Testing sites may require their own screening.
