- NC has had a total 124,006 confirmed cases, with 1,979 deaths. Our state currently has 29,863 active cases and 1,151 hospitalizations.
- Beaufort County has had a total of 370 cases, with 155 currently active, and 7 currently hospitalized. Investigation of these known cases have concluded:
  - o (163) cases are attributed to direct contact with other known positive cases.
  - o (2) cases were related to travel to a known outbreak area.
  - o (70) cases are attributed to community spread.
  - o (135) cases are still under investigation.

Sixty (60) of our total positives were asymptomatic at the time of their test.

All active cases are self-isolating.





• Eastern NC counties with total confirmed cases include: Bertie, (245), Beaufort (370), Bladen (577), Brunswick (1,174), Carteret (286), Camden (62), Chowan (126), Columbus (821), Craven (626), Currituck (70), Dare (198), Duplin (1,924), Edgecombe (574), Gates (43), Greene (305), Halifax (622), Hertford (277), Hyde (37), Jones (58), Lenoir (531), Martin (239), New Hanover (2,322), Northampton (307), Onslow (917), Pamlico (57), Pasquotank (351), Pender (612), Perquimans (65), Pitt (1,739) Sampson (1,417), Tyrrell (91), Washington (118), Wayne (2,299) and Wilson (1,382). Mecklenburg (20,679), Wake (10,969), and Durham (5,830) counties have the most cases.


## **Testing**

- There have been 4,393 tests completed in Beaufort County to date, with 3,844 negatives, 361 positives and 188 pending. (These are cumulative numbers and includes test performed at the Health Department and reporting private medical facilities throughout our county.) \*Nine (9) of our positive cases were tested in other counties but are Beaufort Co. residents. \*
- There were 827 tests conducted in Beaufort County last week. (Week of 7/20/20)





# WHAT CAN YOU DO IF SOMEONE IN YOUR HOME IS SICK

#### **Limit Contact**

- The caregiver, when possible, should not be someone who is at higher risk for severe illness from COVID-19.
- Have the person who is sick use a separate bedroom and bathroom. If possible, have the person who is sick stay in their own "sick room" or area and away from others. Try to stay at least 6 feet away from the sick person.
- Shared space: If you have to share space, make sure the room has good air flow. Open the window to increase air circulation. Improving ventilation helps remove respiratory droplets from the air. Avoid having visitors.
- Avoid having any unnecessary visitors, especially visits by people who are at higher risk for severe illness.

#### **Eat In Seperate Rooms Or Areas**

- Stay separated: The person who is sick should eat (or be fed) in their room, if
  possible.
- Wash dishes and utensils using gloves and hot water: Handle any dishes, cups/glasses, or silverware used by the person who is sick with gloves. Wash them with soap and hot water or in a dishwasher.
- · Clean hands after taking off gloves or handling used items.

#### **Avoid Sharing Personal Items**

 Do not share: Do not share dishes, cups/glasses, silverware, towels, bedding, or electronics (like a cell phone) with the person who is sick.

#### Clean Your Hands Often

- Wash hands: Wash your hands often with soap and water for at least 20 seconds. Tell
  everyone in the home to do the same, especially after being near the person who is
  sirk
- Hand sanitizer: If soap and water are not readily available, use a hand sanitizer that
  contains at least 60% alcohol.
- . Hands off: Avoid touching your eyes, nose, and mouth with unwashed hands.

#### Clean & Then Disinfect

- Clean and disinfect "high-touch" surfaces and items every day: This includes tables, doorknobs, light switches, handles, desks, toilets, faucets, sinks, and electronics.
- Clean the area or item with soap and water if it is dirty. Then, use a household disinfectant.

## Beaufort County Schools - School Openings Announcement

Beaufort County Schools will be starting the 2020-2021 school year on a modified Plan B format for all schools except the BCS Early College High School. Parents and students of ECHS will be contacted directly about their schedule of instruction.

The modified Plan B consists of four weeks of remote instruction for all other students beginning August 17th through September 11th.

Presumably students will then be partially attending schools each week along with continued remote instruction outside the school building. Parents and students will be informed when students attend onsite and when they continue remote instruction. More specific details will be released soon concerning these assignments. Here is an example of the weekly schedule:

Group A Students: Monday/Tuesday in school instruction, Wednesday/Thursday/Friday remote learning

Group B Students: Monday/Tuesday/Wednesday remote learning, Thursday/Friday in school instruction

There will be additional information communicated soon regarding the Open House, learning protocols, device pickup, and learning expectations for each school. Please monitor the website and/or social media account of your child's school.

## **Re-Opening Timeline / Guidelines**

Below is a summary of our states plan for a phased reopening. Please note that these timelines / guidelines are subject to change based on case trends and / or additional executive orders.







## Phase II (Will begin at 5pm Friday, 5/22 and continue through 5pm Friday 8/7)

Governor Cooper has announced that North Carolina's Phase II "Safer at Home" order has been extended for 3 additional weeks (thru 8/7).

Restaurants and Personal Care Services must follow safety protocols including the potential need to reduce capacity. (Bar & Fitness Centers will remain closed under Executive Order 141)

Requires face coverings in public spaces when 6 ft of distancing isn't possible.

#### Phase III (Could begin Aug 7th, 2020)

Increased capacity at Restaurants, Bars, Other Businesses & Entertainment Venues.

Further increase the number of people allowed at gatherings.

• The following Executive Orders have been issued for North Carolina.

- o EO 147: Takes effect on June 26<sup>th</sup> and extends Phase II "Safer at Home" orders and requires the use of face coverings.
- EO 146: Extends certain transportation-related provisions in previous executive orders.

- o EO 144: Extends certain health and human services provisions in previous executive orders.
- o EO 143: Addresses disparities in communities of color that historically have had less access to health care, housing, economic opportunity and more.
- o EO 142: Extends the prohibition of utility shut-offs and implements a moratorium on evictions.
- o EO 141: Lifts the statewide Stay at Home Order and moves the state to a Safer At Home recommendation. Allows restaurants to resume dine-in services, and Barbers, Salons and Personal Care businesses to open.
- o EO 139: Provides additional regulatory flexibility to help ensure capacity in the state's health care system and improve its ability to effectively respond to the COVID-19 pandemic.
- o EO 138: Effective 5 p.m. May 8, 2020, eases some restrictions on travel, business operations and mass gatherings.
- o EO 135: Extends until May 8, North Carolina's Stay At Home (Executive Order 121) as well as other orders regarding the closures of restaurants for dine-in service, bars and other close-contact businesses
- o EO 134: Allows furloughed employees to be eligible for unemployment benefits.
- o EO 133: Extends certain provisions in previous executive orders that are related to transportation.
- EO 131: Addresses three issues: requires retail stores that are still operating to implement new social distancing policies to make shopping safer for customers and employees; makes earlier COVID-19 guidelines mandatory for nursing facilities, and recommends other long-term care facilities to do the same; speeds up the process to get benefits to people out of work.
- o EO 130: Provides more access to health care beds, expands the pool of health care workers and orders essential childcare services for workers responding to the crisis.
- o EO 124: Prohibits utilities including electric, gas, water and wastewater services from disconnecting people who are unable to pay during this pandemic and







prohibits them from collecting fees, penalties or interest for late payment. The order applies for the next 60 days and gives residential customers at least six months to pay outstanding bills.

- EO 121: A statewide "Stay at Home" order has been issued. This order will
  restrict travel to essential activities only. (ie. Travel for items such as, groceries,
  food, medications, household supplies, essential workers, etc.) This order will
  also limit gatherings to less than 10 people.
- EO 120: Extended school closures through May 15<sup>th</sup>. This order also imposes restrictions on the following businesses; Bingo Parlors, Bowling Alleys, Indoor Exercise Facilities, Health Clubs, Indoor / Outdoor Pools, Live Performance Venues, Movie Theaters, Skating Rinks, Spas, Gaming and businesses which allow gaming activities.
- EO 119: Lifting restrictions on local Health Departments, childcare facilities, and commerce transport. This order also restricting various functions of DMV to include:
  - Driver's License Office will operate by appointment only.
  - Closing of all Drivers License Office that are on insufficient size to maintain social distancing.
  - Extending office hours at locations that are of sufficient size.
  - Postpone all DMV related hearings for 60 days.
- o EO 118: Restricting dine-in services at all restaurants / bars. These businesses will continue to be allowed to provide carry-out and delivery services.
